Master Stewardship Agreement

Stewardship Agreements

- Are joint endeavors between Forest Service & Partners with mutual benefits and interests
- Have partners who are state or local governments, tribes, and/or nonprofits
- Require partner cost sharing of 20% or more, in-kind or cash
- Do not allow for profit

Stewardship Agreement Benefits for the FS

- Trade goods for services
- Retain receipts on the National Forest for future stewardship work
- Agreements can be long term (up to 10 years)
- Best value award of contracts and agreements

Supplemental Project Agreements

 Master Stewardship Agreements are used for larger Stewardship areas in conjunction with Supplemental Project Agreements (SPAs), which address specific projects

• SPAs:

- Describe the desired end result of the project(s)
- Designate Forest Service and partner representatives
- Specify the exchange of goods and services
- Include technical specifications for goods sales and service work
- Include maps and descriptions
- Include any necessary forest restrictions and closure dates

Sustainable Resources Institute— Chequamegon-Nicolet National Forest Stewardship

- The Wisconsin Economic Development Corporation (WEDC) desired to improve the economy by increasing management Chequamegon – Nicolet National Forest (CNNF)
- SRI signed an agreement with WEDC in October, 2013 for a six month project to increase management on the CNNF

WEDC-SRI Project Short-term Plan of Work

- Develop a CNNF Steering Committee to identify & prioritize issues
- Research utilization of stewardship contracts and agreements nation-wide
- Develop structure for Stewardship Agreement with the CNNF
- Draft and formalize a Stewardship Agreement proposal
- Partner with pertinent entities to identify qualified applicants for specific contract activities

Chequamegon-Nicolet NF Supplemental Project Agreement 1

- Signed September of 2014 & Completed Fall of 2016
- Goods timber sale (224 acres)
- Service work
 - Timber marking (735 acres)
 - Road reconstruction (2.08 miles)
 - Aspen regeneration (74 acres)
 - Hardwood canopy gap regeneration (139 acres)
 - Road reconstruction (3.10 miles)
 - Stream crossing culvert replacement (1 culvert)
 - ATV Trail reconstruction (3.58 miles)

Chequamegon-Nicolet NF Supplemental Project Agreement 2

- Signed October of 2015 and currently in progress
- 2 Goods timber sales (550+ acres)
- Service work
 - Timber marking (~6,000 acres over 3 years)
 - Boat landing survey & design (7 launches)
 - Boat landing construction (1 launch)
 - Fireline construction (23 acres)
 - Aspen site preparation (80 acres)
 - Site prep for planting (100 acres)
 - Dam repair project (Wyden Authority)

Ottawa National Forest Supplemental Project Agreement 1

- In draft
- Goods timber sale (344 acres)
- Service work
 - Timber marking (1,200 acres)
 - Site preparation
 - Boat landing restoration
 - River crossing & trail restoration
 - Wildlife opening restoration
 - FS road closures
 - FS road maintenance

Lessons Learned

- Each National Forest is unique & each Ranger District is unique
- The ins and outs of Stewardship are new to some FS staff
- The Wyden Authority allows for implementation of projects on non-FS lands
- Indirect costs can be included in the SPA
- When appropriate, sole source contracting can be built into the SPA
- The SPA can be modified if both parties agree
- There's a break even point that's dependent on the value of the goods sale(s)
